VISION PLAN/STRATEGIC PLANNING INITIATIVE: Project is consistent with the Recreational Infrastructure section of the Vision plan, this project will further ensure that the citizens of Daytona Beach have the recreational infrastructure needed to maintain and enhance their quality of life. The City will be responsible for the purchase and installation of a 6' height decorative black square stock perimeter security fence with vehicular access gates and a restricted pedestrian gate for maintenance and emergency response entry and exit. The estimated probable construction cost to the City for the purchase and installation of the approximate 900 linear feet of fence and three gates(two vehicular access and one pedestrian), with each having a security alert system, is approximately \$27,800.00. The County will be responsible for furnishing, installing, operating and maintaining the playground including lighting, security features other than					
the gate mounted alert devices, play equipment, cost of utilities and maintenance of all City property within the fenced playground area at their cost.					
BACKGROUND:The Interlocal Agreement provides for the leasing of certain City property on City Island adjacent to the Regional Library for construction and operation of a children's playground and delineates the installation, administration and maintenance responsibilities for the City and County. The Property will be leased to the County in 5 year increments for up to 25 years at a rate of \$500.00 per 5 year increment.
