












<p><b>BACKGROUND:</b> <u>Contract - Approval - Resolution authorizing the award of the contract with MCG Services, LLC, 1709 Arash Circle, Port Orange, FL 32127 in the amount of \$28,620.00 for the sidewalk improvements along Bill France between Mason Ave and Clyde Morris Blvd.</u></p> <p><u>This request is to construct 63 feet of new sidewalk along Bill France to provide continuity to the existing sidewalk along Mason Ave. In addition, multiple segments of sidewalk along Bill France are damaged and are in desperate need of repair, this contract will facilitate the restoration of this compromised infrastructure.</u></p> <p><u>Funding is available in the Bill France Blvd Sidewalk Account No. 301-600000-541-565000-601701.</u></p>
