<p>BACKGROUND: <u>Ordinance - PUBLIC HEARING - adopting a Large Scale Comprehensive Plan Amendment (LSCPA) changing the Future Land Use Map (FLUM) designation from Volusia County - Conservation (C) to City - Low Intensity Urban (LIU) for 626± acres of land located northwest of Interstate 4 and south of International Speedway Boulevard (ISB); amending the Future Land Use Element to implement the Interlocal Service Boundary Agreement (ISBA) between the City and the County; and amending the Intergovernmental Coordination Element to establish the ISBA as the joint planning agreement required by §171.204, Florida Statutes.
