SUBJECT:	ELC Industries, LLC - Contract No. 0118-0100 - Planter Maintenance

### **REQUEST**

The Public Works Department, Administrative Division, requests the City Commission to:

- 1. Reject the bid submitted by Mark Solomon Properties, Inc. as non-responsive as the bidder failed to complete the bid schedule correctly and, as a result, could not be properly evaluated. Memo to City Manager enclosed.
- 2. Waive informalities in the bid by ELC Industries, LLC, as minor irregularities, consisting of ELC Industries, LLC's erroneous use of its corporate principal's name in the first sentence of the Bid Proposal Form. The Bid Proposal Form otherwise indicates that the bid was being submitted as ELC Industries, LLC.
- 3. Authorize the Mayor and the City Clerk to award and execute a contract with ELC Industries, LLC, 1340 Shangri-La Drive, Daytona Beach, FL 32119 in the amount of \$12,870.00 for remainder of Fiscal Year 2017/2018 (5 months) based on the submitted Fee Schedule for a three (3) year term of \$232,848.00 or \$77,616.00 annually.
- 4. Authorize the City Manager to exercise the option to renew the contract for up two (2) terms of one (1) year each in the total amount of \$77,616.00 annually.

### **PURPOSE**

ELC Industries, LLC will provide as-needed planter maintenance to 196 total planters located at Beach Street and the Main Street District. Scope of work shall include, but is not limited to watering each planter, removing all trash, cigarette butts and foreign materials from planters and dispose offsite, pruning plants as appropriate/directed to promote healthy growth and to remove dead leaves and plants to ensure a clean appearance three (3) times a week on evenly spaced days; service specifics referenced in Exhibit A: Scope of Services of contract.

# **CONSIDERATIONS**

Continual planter maintenance will provide beautification enhancements to the City of Daytona Beach. All work must be performed when visitor traffic is low so pedestrian activities are not interrupted. The Contract Administrator or its designee must be notified of any deviations from the established schedule.

Future funding is subject to commission approval of future budgets.

# **RECOMMENDATIONS**

It is recommended City Commission authorizes the Mayor and the City Clerk to execute and award a planter maintenance contract with the lowest responsive bidder, ELC Industries, LLC, in the amount of \$12,870.00 for remainder of the Fiscal Year 2017/2018, based on the submitted Fee Schedule for a three (3) year term with option to renew for up two terms of one (1) year each in the total amount of \$77,616.00 annually.
