









| <p>BACKGROUND: <u>Request a Resolution to accept a public sidewalk easement being granted by Consolidated Tomoka Land Company and Indigo Development LLC.</u></p> <p><u>Consolidated Tomoka Land Co and Indigo Development LLC is requesting the City to accept a sidewalk easement in order to facilitate the current Buc-ee's project. The easement is on property owned by Consolidated Tomoka Land Co and Indigo Development LLC that is located east of the Buc-ee's Center. Approximately 479 feet of the new sidewalk needs to be placed outside of Gateway North Drive's right of way to accommodate the necessary roadway improvements.</u></p> <p><u>No funding is needed to accept the public sidewalk easement.</u></p> | | | | | | | | | |
