


**BACKGROUND:** The Public Works Department/Facilities Property Maintenance Division requests the City Commission award a one-year contract with 3 one-year renewal options for the annual swimming pool maintenance at the Breakers Park Splash Pad and Oceanfront Clock Tower Fountain, to the lowest, responsive and responsible bidder, Blue Ribbon Pools, 400 Venture Drive, Suite A, South Daytona, Florida 32119, in the amount not to exceed \$26,120.00.

The Facilities Property Maintenance Division is responsible for the maintenance of the Breakers Splash Pad and Oceanfront Clock Tower. This annual contract will provide daily pool equipment maintenance services, and chemicals to the Breakers splash pad and clock tower fountain pool. Of the 141 invitations sent, three responses were received to the Invitation to Bid, as shown on the attached Bid Tabulation Sheet.

**STAFF/BOARD RECOMMENDATION:** It is recommended the City Commission accept the lowest responsive and responsible bid from Blue Ribbon Pools for the monthly swimming pool maintenance contract at the Breakers Park Splash Pad and Oceanfront Clock Tower Fountain, for an amount not to exceed \$26,120.00.

Further request the City Manager be authorized to exercise the renewal options.
