PURPOSE:

The purpose of this board item is to purchase replacement vehicles for multiple departments.

CONSIDERATION:

The requested replacement vehicles are budgeted in the FY 2018-2019 budget and are part of the overall vehicle replacement program for the City. Sixteen vehicles will be disposed by the Purchasing Department upon receipt of the replacement vehicles either internally or by way of auction.
