BACKGROUND: Business Enterprise Management Department (BEMD) requests the City Commission adopt a resolution authorizing the purchase of a Sanitary Sewer Combination Cleaner Vehicle from the Sourcewell Cooperative Contract 122017-FSC with options from Environmental Products of Florida, 2525 Clarcona Road, Apopka, FL 32703 in the net amount after trade-in of \$348,360.46.

The purpose of this request is to purchase a replacement vehicle for Utilities - Stormwater.




The requested replacement vehicle for a 2006 Sanitary Sewer Combination Cleaner vehicle with a trade-in value of \$22,000.00 is budgeted in the FY 2018-2019 budget and is part of the overall vehicle replacement program for the City. One piece of equipment will be disposed by trade-in as part of this transaction.

Funds for the net amount of \$348,360.46 are available in the Stormwater Improvement Fund 460-610417-538-564001-000000.
