### REQUEST

Public Works is requesting City Commission to authorize the Mayor and the City Clerk to execute a Construction Contract with the lowest responsive bidder, Saboungi Construction Inc., 290A North Highway 1, Ormond Beach, FL 32174 in the amount of \$94,842.00 for the Bethune Point Observation Pier Repair.

### PURPOSE

This item provides for the repair of the Bethune Point Park Observation Pier that sustained piling and boardwalk damage during Hurricane Irma. The pier abruptly lifted as result of the storm surge generated during Hurricane Irma, destroying components of the pier.

### CONSIDERATION

A portion of this pier has been compromised and is no longer accessible to the public. Since this damaged occurred during Hurricane Irma the project is potentially eligible for 75% (\$71,131.50) cost share from Federal Emergency Management Agency (FEMA) and an additional 12.5% (\$11,855.25) cost share from the State of Florida. Five (5) construction bids were received on November 14, 2018, with Saboungi Construction Inc. being the lowest responsive bidder. The construction bid summary is as follows:

### FUNDING

Funding in the amount of \$82,986.75 is available in the FEMA – Hurricane Irma Fund account 195-950000-539-565000-951702 and \$11,855.25 in the General Fund (001).

### RECOMMENDATION

Deputy Public Works Director is recommending the City Commission authorize the Mayor and the City Clerk to execute a Construction Contract with the lowest responsive bidder, Saboungi Construction Inc., in the amount of \$94,842.00 for the Bethune Point Park Observation Pier Repair.
