BACKGROUND: The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance,					
FY 2018 Bulletproof Vest Partnership Program, provides federal funds to outfit sworn officers with bulletproof					
vests. This grant pays for 50% of the ballistic vest costs totaling \$30,000 and the City of Daytona Beach is					
responsible for the remaining 50% match of \$30,000. The combined total funding amount (federal award +					
match) is not to exceed \$60,000. This will purchase the mandatory replacement of 60-70 (depending on refits)					
ballistic vests from Dana Safety Inc. under NASPO Body Armor 2016-2021 contract. The match funding will					
come from the LETF-Fed Equitable Sharing Fund. A Sufficiency of Funds is included to show availability of					
funds for the continuation of the Daytona Beach Police Department's participation in the Bulletproof Vest					
Partnership Program.
