The relocation is necessary to facilitate the upcoming Riverfront Park improvements currently anticipated to commence in February 2020. This project has been bid two separate times and there isn't enough time to bid the project a third time. The Dr Josie Rogers house needs to be relocated before the park improvements start at the north end of the park.
